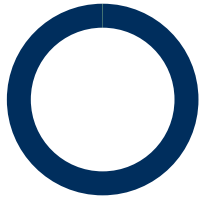

Asset mix (%)



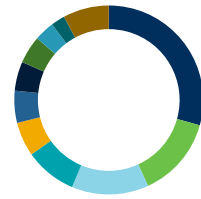
