■ WHAT DOES THE FUND INVEST IN?

The Fund invests in Fidelity Insights Investment Trust[™] (the underlying fund), which aims to achieve long-term capital appreciation by investing primarily in equity securities of companies anywhere in the world, with an emphasis on U.S. securities, whose value is believed to be not fully recognized by the public.

The charts below give you a snapshot of the underlying fund's investments on September 30, 2024. The underlying fund's investments will change.

■ HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

Fidelity has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

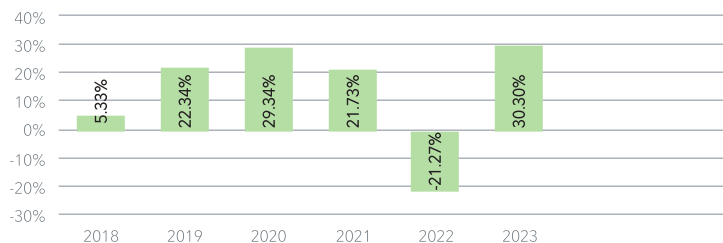


■ HOW HAS THE FUND PERFORMED?

This section tells you how Series F8 shares of the Fund have performed over the past 6 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

YEAR-BY-YEAR RETURNS

This chart shows how Series F8 shares of the Fund performed in each of the past 6 years. The Fund dropped in value in 1 of the 6 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



■ WHO IS THIS FUND FOR?

Investors who:

- plan to hold their investment for the medium- to long-term
- want to gain global equity exposure with an emphasis on U.S. securities
- can handle the volatility of returns generally associated with equity investments
- want to receive tax-efficient monthly distributions
- may be looking to benefit from combined management and administration fee rebates based on the amount of their investment in the Program

The Fund is not an appropriate investment if you have a short-term investment horizon.

Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns.

■ HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series F8 shares of the fund. The fees and expenses - including any commission - can vary among the series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

Series F8 shares of the Fund are automatically included in the Program. The Program offers management and administration fee reductions, paid in the form of reinvested distributions ("fee rebates"), that increase progressively with assets, resulting in lower combined management and administration fees (before sales tax) than otherwise. We will automatically apply fee rebates on your Series F8 shares of the Fund when you meet the applicable investment threshold. If you no longer meet the applicable investment threshold for a particular tier of fee rebates, we will automatically decrease the amount of the fee rebates to a lower tier, which will result in higher combined management and administration fees (before sales tax) but that will not exceed the Series F8 combined management and administration fees. 1 SALES CHARGES

You do not pay any sales charge when you buy or sell Series F8 shares of the Fund.

BEST AND WORST 3-MONTH RETURNS

This table shows the best and worst returns for Series F8 shares of the Fund in a 3-month period over the past 6 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

AVERAGE RETURN

A person who invested \$1,000 in Series F8 shares of the Fund on the inception date now has \$3,353. This works out to an annual compound return of 17.1%.

■ A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).

Keep in mind that if you hold your fund in a non-registered account, fund distributions that are not a return of capital are included in your taxable income, whether you get them in cash or have them reinvested.

Fund distributions that are a return of capital are not included in your taxable income, but will affect your capital gains or losses on disposition.

■ FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the return you get on your investment.

As of May 31, 2024, the Fund's expenses were 1.10% of its value. This equals \$11.00 for every \$1,000 invested.

Management expense ratio (MER)

This is the total of the Fund's management fee (including the trailing commission), fixed administration fee, and certain operating expenses (fund costs). Fidelity waived some of the Fund's expenses. If it had not done so, the MER would have been higher.

These are the Fund's trading costs.

More about the trailing commission

Trailing commissions are not paid on Series F8 shares.

■ OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

FEE	WHAT YOU PAY
Short-term trading fee	If you sell/switch shares within 30 days of the most recent purchase/switch into the Fund, you <i>may</i> be charged 1% of the value of those shares or have your account restricted/closed. This fee goes to the Fund.
Switch fee	Your representative's firm may charge you up to 2% of the value of shares you switch to another series of the Fund or another Fidelity Fund.
Fee-for-service	You may buy and hold this series of shares in a fee-for-service account at your representative's firm or through your discount broker (if your representative's firm or discount broker offers Series F). If you hold your shares in a fee-for-service account, you may pay a fee directly to your representative's firm or your discount broker.
Advisor service fee	If you do not hold this series of shares in a fee-for-service account where your representative's firm may charge you a fee directly, you may opt to enter into an advisor service fee agreement between you, your representative's firm and Fidelity. If you enter into an advisor service fee agreement, Fidelity will collect the advisor service fee (plus any applicable taxes) from you on behalf of your representative's firm by redeeming shares of this series of the Fund and remitting the amount to your representative's firm. Where such an arrangement exists, the maximum annual advisor service fee that we will collect on behalf of your representative's firm is 1.50% (excluding applicable taxes).
Fee for sizable redemptions	If you have been notified that you own a sizable percentage of a Fund, you <i>will</i> be subject to a 1% penalty of the value of the shares that you sell/switch if you sell/switch your shares of the Fund within 30 days of your most recent purchase/switch into the Fund. You <i>may</i> be subject to a 1% penalty of the value of the shares if you fail to provide the required notice to Fidelity prior to completing a sizable redemption. This fee goes to the Fund.

■ WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
