### **Management Discussion of Fund Performance**

### **Investment Objective and Strategies**

Investment Objective: Fidelity Advantage Bitcoin ETF Fund<sup>®</sup> (Fund) seeks a similar return to its underlying fund, which is also managed by Fidelity, by investing substantially all of its assets in units of that fund. The underlying fund aims to invest in bitcoin. Currently the underlying fund is Fidelity Advantage Bitcoin ETF<sup>®</sup> (Underlying Fund).

Strategies: In order to achieve its investment objective, the Underlying Fund invests primarily in bitcoin. The direct long-term holdings of bitcoin are purchased or received by the Underlying Fund only from acceptable bitcoin sources. An acceptable bitcoin source means a trading platform or venue or over-the-counter counterparty that (i) is registered or exempt from registration as a dealer or a marketplace in Canada or (ii) is regulated as a trust company or a broker-dealer under the laws of a state of the United States and, in each case, is required under such registration or by its regulator, as the case may be, to comply with applicable know-your-client requirements and AML regulation. Each acceptable bitcoin source is a spot market where bitcoin source in order to confirm its reputation and stability. This due diligence includes conducting research on the executive officers and significant shareholders and confirming that each acceptable bitcoin source maintains appropriate know-your-client policies and procedures and complies with AML regulation. In addition to receiving or purchasing bitcoin directly, the Underlying Fund may, from time to time, purchase or enter into derivatives that provide economic exposure to bitcoin, but any use of derivatives will be incidental to the Underlying Fund's primary investment strategy of investing directly in bitcoin. Currently, it is expected that the Underlying Fund will purchase only bitcoin futures. Any use of derivative instruments by the Underlying Fund must be in compliance with the requirements in NI 81-102 that apply to alternative mutual funds and any exemptive relief obtained by the Underlying Fund from the requirements of NI 81-102. The Underlying Fund will not use derivatives to leverage the investment portfolio of the Underlying Fund. In addition, no currency hedging is entered into by the Underlying Fund in respect of the USD Units. Purchasing USD Units does not hedge — or protect — against losses caused by changes in the exchange rate between the Canadia

### Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for long-term investors who want to look for a liquid alternative mutual fund strategy that provides exposure to bitcoin, and can handle the volatility of returns generally associated with bitcoin. The Fund is not an appropriate investment for investors with a short-term investment horizon. To invest in the Fund, investors should be willing to accept a high level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

### **Results of Operations**

Fidelity Advantage Bitcoin ETF Fund<sup>®</sup>, Series B, returned 141.1%, after fees and expenses, for the one-year period ended March 31, 2024. The net returns of the other series of this Fund are similar to those of Series B, except for differences attributable to expense structures.

### Factors affecting performance:

As a single-asset fund, the Fund's performance was driven solely by the performance of bitcoin. Over the period under review, bitcoin outperformed major stock and bond indexes. The strong performance for bitcoin was primarily driven by the Securities Exchange Commission (SEC)'s approval for spot bitcoin ETFs in the U.S., investors preference for risk-assets amid expectations of looser monetary policy, and lower investor confidence in the fractional reserve banking system.

Throughout 2023, there was much speculation over the SEC's approval for a spot bitcoin ETF. During the year, bitcoin faced headwinds due to the SEC's lawsuits against key crypto exchanges Coinbase and Binance. However, the fears over legal scrutiny proved to be short lived, as bitcoin's price momentum continued throughout much of 2023. By June, both Fidelity and BlackRock filed for spot bitcoin ETFs in the U.S. When the approval was obtained in January 2024, there proved to be elevated demand from investors seeking exposure to the asset class without the complications of self-custody.

Another key catalyst for the outperformance was the collapse of Silicon Valley Bank (SVB) in March 2023, which served to weaken investor sentiment in the centralized and regulated financial system. Investor preference for decentralized currencies rose as they vied for a more secure outlet than traditional fiat currencies.

Portfolio changes:

During the period, the Underlying Fund's position in bitcoin was increased in line with share creations, and also trimmed in line with share redemptions.

### **Recent Developments**

The Underlying Fund's portfolio managers, Edward Lui and Reetu Kumra, continue to invest in line with the strategy set out in the Underlying Fund's investment objective.

The cryptocurrency market continues to evolve. Although regulatory challenges remain, the recent launch of spot bitcoin ETFs in the U.S. serves as a pivotal point in the crypto space, with 11 approved applications on January 10, 2024. Additionally, in January 2024, the Canadian Securities Administrators (CSA) published proposed amendments to the regulations for public

investment funds holding crypto assets. The proposed amendments are part of the second phase of the wider project aimed at amending regulations for public funds with exposure to crypto assets.

Effective September 19, 2023, Anne Bell of Mississauga, Ontario, became a member of the Independent Review Committee (IRC).

### **Related Party Transactions**

### **Manager and Portfolio Adviser**

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity provides investment advice with respect to the Fund's investment portfolio and arranges for the acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$49,000 for the period ended March 31, 2024.

### Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$22,000 for the period ended March 31, 2024.

### **Brokerage Commissions**

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non-affiliated, qualified brokerage firms, on an execution-only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$0 for the period ended March 31, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

### Independent Review Committee, Cross-Trading and In specie Transactions

### Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

### **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate is nonuclized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

### **Management and Advisory Fees**

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.





### Year-by-Year Returns



A discussion of Fund performance can be found in the Results of Operations section of this report. The Fidelity Bitcoin Index is an index designed to reflect the performance of bitcoin in U.S. dollars. It uses bitcoin price data from eligible trading platforms and a volume weighted median price method based on the 5-minute window immediately prior to the 4:00 p.m. (ET) close. The Fidelity Bitcoin Index price is calculated by ordering all individual transactions occurring over this 5-minute time frame on the eligible trading platforms and selecting the price associated with the 50th percentile of total volume. The Fidelity Index Committee reviews the Fidelity Bitcoin Index semiannually for possible updates as a result of the maturation of the digital assets industry. In addition, the Fidelity Index Committee and the Fidelity Digital Asset Services Advisory Committee evaluate semi-annually all U.S. digital asset trading platforms and/or regulated digital asset trading platforms and may change the eligible trading platforms at that time or during market disruptions when a trading platform review is warranted. Each eligible trading
