#### **Management Discussion of Fund Performance**

#### **Investment Objective and Strategies**

Investment Objective: Fidelity Canadian Asset Allocation Fund (Fund) aims to achieve high total investment return using an asset allocation approach. The Fund invests primarily in a mix of Canadian equity securities, fixed income securities, and money market instruments.

Strategies: The Fund's neutral mix is 70% equity securities, 30% fixed income securities. Depending on market conditions, the portfolio managers may vary the Fund's asset mix from the neutral mix if they believe this will produce the best overall return. The portfolio managers generally keep the Fund's asset mix within the following ranges: 20.0%—90.0% equity securities, 10.0%—60.0% fixed income securities, and 0.0%—70.0% money market instruments. The Fund may also hold cash and may invest in any kind of equity or fixed income security or money market instrument. This includes high-yield securities, other lower-quality debt securities, Canadian or foreign securities. The Fund may invest in underlying funds, each of which may, in turn, invest more than 10% of its net assets in other underlying funds managed by Fidelity (Third Tier Funds). The portfolio management team of any underlying fund may change the percentage of assets invested in a particular Third Tier Fund at any time. The portfolio management team decides which asset class a security belongs to, based on its investment characteristics, and may invest in other securities that do not fall withing these classes. The Fund may also invest up to 40% of its net assets in foreign securities, invest in China A-Shares, invest a portion of its fixed income assets in non-investment grade U.S. high yield debt securities or convertible securities, which portion of the Fund tends to have a higher credit risk than the domestic investment grade fixed income portion of the Fund.

When buying and selling equity securities, the portfolio management team examines each company's potential for success based on its current financial condition and industry position, as well as economic and market conditions. The portfolio managers consider factors such as growth potential, earnings estimates and quality of management. When buying and selling fixed income securities, the portfolio management team analyses other factors, such as its features, prices compared to estimated long-term value, credit quality of the issuer and any short-term trading opportunities resulting from market inefficiencies.

The portfolio management team uses the FTSE Canada Universe Bond Index as a guide to structuring the domestic investment-grade fixed income portion of the Fund. While the portfolio management team generally manage this portion of the Fund to have overall interest rate risk similar to that of the index, the Fund's specific investments may or may not be included in the index.

The Fund, any underlying fund and Third Tier Fund may also enter into repurchase agreements, reverse repurchase agreements and securities and lending transactions, use derivatives for hedging and non-hedging purposes as well as invest in precious metals and other physical commodities through commodity ETFs and/or derivatives. They may also invest in securities of underlying funds, which may include liquid alternative mutual funds, selected in accordance with the Fund's investment strategies.

#### Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for medium- to long-term investors who want to gain exposure to both Canadian equity and fixed income securities, want the convenience of a diversified portfolio in a single fund, and can handle the volatility of returns generally associated with equity investments. The Fund is not an appropriate investment for investors with a short-term investment horizon. To invest in the Fund, investors should be willing to accept a low to medium level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

#### **Results of Operations**

Fidelity Canadian Asset Allocation Fund, Series B, returned 8.9%, after fees and expenses, for the year ended June 30, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, Canadian Equities, as represented by the S&P/TSX Composite Index, returned 12.1% (in Canadian Fixed Income, as represented by the FTSE Canada Universe Bond Index, returned 3.7% (in Canadian dollar terms).

#### Market overview:

Canadian equities, as measured by the S&P/TSX Composite Index, returned 12.1%, for the one-year period ended June 30, 2024.

Canadian equities advanced for the period under review. Increases in cyclically sensitive sectors, such as energy and materials, were driven by rising oil and commodity prices. Financials also rose, supported by the general health of the Canadian banking sector. However, there were modest signs of stress among smaller businesses and households due to high leverage and the impact of prior rate hikes. In contrast, the communication services and real estate sectors faced headwinds, particularly towards the end of the review period. These sectors were pressured by higher interest rates and a shift in consumer spending patterns. A stable domestic economic environment, resilient growth in the U.S. economy, combined with a general trend towards lower inflation supported investor sentiment. The annual inflation rate fell to 2.7% in April 2024 from 2.9% in March 2024, due to slower growth of food prices. Despite an increase in the unemployment rate to 6.2% in May 2024, job creation surpassed expectations, indicating underlying economic resilience. The Bank of Canada (BoC) forecasts GDP growth of 1.5% in 2024 and 2.2% in 2025. Based on this outlook, the BoC lowered its policy rate by 25-basis points to 4.75% in June 2024, the first rate cut in four years and signalled a shift towards more accommodative monetary policy as inflation pressures moderated.

Canadian investment-grade bonds, as broadly represented by the FTSE Canada Universe Bond Index, returned 3.7% one-year period ended June 30, 2024.

Canadian investment-grade bonds rose over the period under review. High yield bonds outperformed their investment-grade peers, benefitting from higher yields and tighter credit spreads. After maintaining a policy rate of 5.0% since July 2023, the Bank of Canada (BoC) reduced the policy rate to 4.75% in June 2024. The BoC noted that there has been continued easing in inflationary pressures in Canada. The BoC also discussed that while labour market data indicates that businesses are still hiring, employment growth has lagged behind the expansion of the working age population, and wage pressures may gradually moderate as a result. Shifts in macroeconomic indicators have contributed to changing investor sentiment over the review period. This is evidenced by the Canada 10-year Treasury Bond yield, which, after a sharp decline in November and December 2023, demonstrated an overall upward trend in early 2024. The BoC's rate reduction in June 2024 caused another decline in the 10-year Treasury bond yield towards the end of the review period.

Factors affecting performance:

The Fund's benchmark returned 9.6% for the period under review. This blended benchmark consists of 70.0% S&P/TSX Capped Composite Index and 30.0% FTSE Canada Universe Bond Index.

The Fund underperformed its benchmark for the period. Among asset classes, the Fund's out-of-benchmark exposure to long-term U.S. Treasury bonds, Canadian real return bonds and Canadian long-term government bonds detracted from relative returns. Conversely, lower-than-benchmark exposures to Canadian investment-grade bonds and to Canadian equities contributed to relative returns. An out-of-benchmark exposure to emerging markets equities also contributed to relative returns.

Among the Fund's holdings in Canadian equities, a lower-than-benchmark exposure to the energy sector and investments in the health care sector detracted from relative returns. In the energy sector, a lower-than-benchmark exposure to Canada-based integrated energy company Suncor Energy detracted from relative returns. In the health care sector, an investment in Canada-based eye health products company Bausch & Lomb detracted from relative returns. In other sectors, a lower-than-benchmark exposure to Canada-based insurance company Manulife Financial Corporation and an investment in Canada-based telecommunications firm Rogers Communications detracted from relative returns.

In contrast, the Fund's investments in the information technology sector contributed to relative returns, particularly an investment in Canada-based software firm Constellation Software and an out-of-benchmark exposure to U.S.-based multinational technology company Microsoft. Investments in the industrials sector also contributed to relative returns, particularly an investment in Canada-based engineering company AtkinsRéalis and an out-of-benchmark exposure to U.S.-based maritime transport firm Kirby. In other sectors, a lower-than-benchmark exposure to Canada-based telecommunications company BCE and to Canada-based banking and financial services company Toronto-Dominion Bank contributed to relative returns.

#### Portfolio changes:

During the review period, portfolio managers David Wolf and David Tulk increased exposure to Canadian equities and long-term U.S. Treasury bonds, owing to the relatively attractive risk/reward outlook for those asset classes in their view. In contrast, the portfolio managers decreased the Fund's exposure to Canadian investment-grade bonds and Canadian long-term government bonds, in favour of what they believed to be better risk/reward opportunities elsewhere.

Among Canadian equities, the equity portfolio managers increased the Fund's exposure to the materials and energy sectors. In the materials sector, exposure was increased to Canada-based diversified metals and mining firm Teck Resources. In the energy sector, exposure was increased to Canada-based oil and natural gas firm Canadian Natural Resources. The portfolio managers believe that these companies have an attractive risk/reward outlook.

In contrast, exposure to the communication services and consumer discretionary sectors was reduced. In the communication services sector, the portfolio managers reduced exposure to Rogers Communications. In the consumer discretionary sector, exposure was reduced to Canada-based automotive parts manufacturer Magna International. The portfolio managers believed there were opportunities with more attractive risk/reward potential elsewhere.

Canadian equities positioning is generally determined by fundamental ideas, rather than top-down sector calls, in the portfolio managers' view. At the end of the review period, the Fund had its largest absolute exposure to the industrials sector, followed by the financials sector. The Fund diverged most from its benchmark's sector weightings by having more exposure to the industrials sector and less exposure to the financials sector.

#### Derivatives disclosure:

During the period, the Fund engaged in futures contracts, in a manner consistent with its investment objective and strategies, to manage the Fund's cash balance while the portfolio management team sought out other investment opportunities.

During the period, the Fund engaged in forward foreign currency contracts, in a manner consistent with its investment objectives and strategies, to hedge against the effect of currency fluctuations on the investment returns of the Fund. The use of forward contracts in this manner does not completely eliminate the impact of currency fluctuations on returns.

#### **Recent Developments**

Portfolio managers David Wolf and David Tulk observe that robust economic activity persists in developed markets, despite some early signs of slowing due to tighter financial conditions, however Canada has shown anemic growth. The portfolio managers believe that although the effects of heightened productivity may not be immediately discernible, advancements in artificial intelligence, coupled with the ongoing prevalence of remote work arrangements, have likely contributed to productivity gains. With headline inflation continuing to moderate, the portfolio managers note that that central banks may not feel the need to maintain such stringent monetary policy. We have already seen Europe, as well as Canada, take the first step in cutting their policy rate. The portfolio managers note that a debate remains on how many interest rate cuts will happen, and when, but the direction of monetary policies is likely to be towards loosening. Against this backdrop, the portfolio managers have become more constructive, but continue to hold certain allocations which may provide some defense in a multi-asset portfolio, as the traditional method of holding bonds for diversification remains unreliable with the correlation between stocks and bonds continuing to be positive. In their view, constructing portfolios that are well diversified across asset classes, styles and regions is the right way to both protect and grow capital over the long run.

Effective September 19, 2023, Anne Bell of Mississauga, Ontario, became a member of the Independent Review Committee (IRC).

#### **Related Party Transactions**

#### Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities, including Fidelity Management & Research Company LLC. With respect to the Fund, Fidelity Management & Research Company LLC has entered into a further sub-advisory agreement with Fidelity Management & Research (Canada) ULC to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$30.713.000 for the period ended June 30, 2024.

#### **Administration Fee**

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$2,719,000 for the period ended June 30, 2024.

#### **Brokerage Commissions**

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non—affiliated, qualified brokerage firms, on an execution—only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were less than \$500 for the period ended June 30, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

#### Independent Review Committee, Cross-Trading and In specie Transactions

#### **Independent Review Committee**

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

#### **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

The increase (decrease) from operations is based on the weighted average number of securities outstanding over the financial period. This table is not intended to be a reconciliation of beginning to ending net assets per security.
- Distributions were paid in cash or reinvested in additional securities of the Fund, or both, and excludes any applicable distributions of management fee reduction to securityholders. Distributions are presented based on management's best estimate of the tax character.
- This information is provided as at period end of the year shown.
- Prior period amounts may have been adjusted.
- Management expense ratio is based on total expenses (excluding distributions, commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset values during the period, including the Fund's pro-rata share of estimated expenses incurred in any underlying investment fund, if applicable, (2024: .01%, 2023: .01%, 2022: .01%, 2020: .01%).

The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate includes any proceeds from a short sale in the value of sales of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.
- Effective October 1, 2015, the manager of the Fund has waived a portion of its administration fee and as of the date of the MRFP has continued to provide the Fund with such waivers. The manager may terminate the waiver at any time, at its sole discretion. It is not known when such waivers will be terminated.

#### **Management and Advisory Fees**

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.

The FTSE Canada 91-Day T-Bill Index is a measure of the Canadian treasury bill market.

Effective April 12, 2019, the FTSE TMX Canada indices were renamed as FTSE Canada indices as a result of FTSE Russell's acquisition of FTSE TMX Global Debt Capital Markets Limited. Each Series will have different returns because of differences in management fees and expenses.
