Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Fidelity Emerging Markets Class (Fund) aims to achieve high total investment return. It seeks a return similar to that of Fidelity Emerging Markets Fund (Underlying Fund) by investing substantially all of its assets in securities of the Underlying Fund. The Underlying Fund, also managed by Fidelity, aims to achieve high total investment returns by investing primarily in equity securities of companies in emerging markets countries.

Strategies: The Underlying Fund's investments are normally diversified across different emerging markets. When buying and selling securities for the Underlying Fund, the portfolio manager examines each company's potential for success in light of its current financial condition and industry position, as well as economic and market conditions. The Underlying Fund may invest in any size of companies and may hold cash and invest in fixed income securities.

Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for long-term investors who want to gain exposure to companies in emerging markets, and can handle the volatility of returns generally associated with equity investments in emerging markets. Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns. To invest in the Fund, investors should be willing to accept a medium to high level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

Results of Operations

Fidelity Emerging Markets Class, Series B, returned 16.4%, after fees and expenses, for the twelve-month period ended November 30, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI World Index, returned 32.0% (in Canadian dollar terms).

Market overview:

Global equities, as broadly measured by the MSCI World Index, returned 32.0% in Canadian dollar terms and 27.8% in U.S. dollar terms, for the one-year period ended November 30, 2024

Global equities advanced for the period under review. Falling interest rates in major developed markets, decreasing inflation, and positive U.S. economic data, helped support investor confidence. Investor optimism in the digital innovation and artificial intelligence space helped fuel growth in the information technology and communication services sectors, propelling the technology-heavy NASDAQ Index to record highs. However, investor sentiment shifted later in the review period due to concerns about stretched valuations and relatively weaker U.S. economic growth. Valuations of companies in the financials sector rose, signalling optimism about potential earnings growth from reduced borrowing costs. Defensive sectors, such as utilities and consumer staples, also gained as investors looked for stability amidst ongoing market volatility. In Europe, equities surged despite some volatility along the way. Markets recovered as the European Central Bank implemented rate cuts, and China's central bank embarked on its most significant stimulus since the pandemic, in effort to ease the deflationary cycle. Japanese equities experienced volatility, amid shifting monetary policy expectations. The interest rate hike by the Bank of Japan led to a rapid unwinding of leveraged global trades, which created market volatility.

Factors affecting performance:

The Fund underperformed its broad-based benchmark, the MSCI World Index. The Fund's investments in the financials and information technology sector detracted from the relative returns.

The Fund's benchmark, the MSCI Emerging Markets Index, returned 16.1% during the review period. The Fund outperformed its benchmark, primarily due to the Underlying Fund's exposure to certain stocks in the materials sector, where an investment in India-based chemicals firm Solar Industries, and out-of-benchmark exposure to Chile-based mining firm Antofagasta, contributed to relative returns. Investments in the communication services sector also contributed to relative returns. In the sector, an investment in China-based internet and technology firm Tencent Holdings, and out-of-benchmark exposure to Netherlands-based internet content and information firm Nebius Group, contributed to relative returns. In other sectors, investments in China-based consumer services firm Meituan, China-based insurance firm China Life Insurance, and Taiwan-based semiconductor company Taiwan Semiconductor Manufacturing, contributed to relative returns.

In contrast, investments in certain stocks in the consumer staples sector detracted from relative returns. In the sector, an investment in Mexico-based consumer staples distribution and retail firm Wal Mart De Mexico, and China-based food and beverages firm Kweichow Moutai, detracted from relative returns. Investments in the information technology sector, particularly, an investment in South Korea-based technology hardware and equipment firm Samsung Electronics, as well as a lack of exposure to a Taiwan-based technology hardware and equipment firm, also detracted from relative returns. In other sectors, investments in China-based consumer discretionary distribution and retail firm PDD Holdings, and China-based private education services firm New Oriental Education and Technology Group, detracted from relative returns.

Portfolio changes:

During the review period, the Underlying Fund's exposure to the financials and energy sectors was increased. In the financials sector, the portfolio manager initiated a position in Poland-based banks firm PKO Bank. In the energy sector, a position was initiated in United Arab Emirates-based oil and gas refining and marketing firm Adnoc Gas. The portfolio manager believes these companies have better-than-average investment growth potential.

In contrast, exposure to the materials and consumer discretionary sectors was decreased. In the materials sector, the portfolio manager exited a position in Canada-based gold firm Barrick Gold. In the consumer discretionary sector, a position was exited from China-based consumer discretionary distribution and retail firm Alibaba Group, in favour of what the portfolio managers believed to be better investment opportunities elsewhere.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the financials sector, followed by the information technology sector. The Underlying Fund diverged the most from the benchmark sector weightings by having more exposure to the industrials sector and less exposure to the information technology sector.

Recent Developments

Portfolio manager Sam Polyak remains positive on the equity market despite the recent rise in volatility. The manager continues to navigate this market environment with a focus on long-term secular trends and is beginning to find value in quality companies in emerging markets. With more than 20 years of emerging markets investment experience, the portfolio manager manages the Underlying Fund as a concentrated strategy with a "growth at a reasonable price" (GARP) investment style. Overall, the portfolio manager remains confident regarding emerging markets in the long term, based on favourable demographics, rapid urbanization and changing lifestyle preferences that should continue to support growth in emerging markets. The manager continues to focus on companies that appear to have strong growth prospects, good management teams and solid market positions, coupled with high barriers to entry. The portfolio manager believes that existing global macroeconomic concerns could make it possible to find such companies trading at more reasonable valuations. Recent increased volatility has had a significant effect on the rerating and multiples of emerging markets equities, which are beginning to look attractive on a relative price-to-earnings basis, in the portfolio manager's view. The Underlying Fund is oriented with a long-term perspective and focuses on the fundamentals of each position and each company's ability to capitalize on long-term structural developments in emerging markets economies. The portfolio manager is analyzing the effects of risks on a stock-by-stock basis and continues to look for opportunities to add to the Underlying Fund's concentrated portfolio of fundamentally strong, growing emerging market companies.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$3,081,000 for the period ended November 30, 2024.

Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$498,000 for the period ended November 30, 2024.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c)

comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

- B Net assets and distributions are based on the actual number of securities outstanding at the relevant time. The increase (decrease) from operations is based on the weighted average number of securities outstanding over the financial period. This table is not intended to be a reconciliation of beginning to ending net assets per security.
- C Distributions were paid in cash or reinvested in additional securities of the Fund, or both, and excludes any applicable distributions of management fee reduction to securityholders.
- This information is provided as at period end of the year shown.
- Prior period amounts may have been adjusted.
- Management expense ratio is based on total expenses (excluding distributions, commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset values during the period, including the Fund's pro-rata share of estimated expenses incurred in any underlying investment fund, if applicable.
- 6 Effective November 1, 2014, the manager of the Fund has waived a portion of its administration fee and as of the date of the MRFP has continued to provide the Fund with such waivers. - He trading expense ratio represents total commissions, other portfolio transaction costs and dividends and interest expense on securities sold short expressed as an annualized percentage of daily average net asset value during the period, including the Fund's pro-rata share of estimated trading costs incurred in any underlying investment fund, if applicable.
- The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate includes any proceeds from a short sale in the value of sales of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.




Past Performance


