Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Fidelity Far East Class (Fund) aims to achieve long-term capital growth and seeks a return similar to that of Fidelity Far East Fund (Underlying Fund) by investing substantially all of its assets in securities of the Underlying Fund. The Underlying Fund aims to achieve long term capital growth by investing primarily in equity securities of companies located or operating in Southeast Asia. These countries include Australia, Hong Kong, India, Indonesia, Malaysia, New Zealand, the People's Republic of China, the Philippines, Singapore, South Korea, Taiwan, and Thailand. The Underlying Fund does not invest in Japan.

Strategies: When buying and selling securities for the Underlying Fund, the portfolio managers examine each company's potential for success considering its current financial condition and industry position, as well as economic and market conditions. The portfolio managers consider factors such as growth potential, earnings estimates and quality of management. The Underlying Fund may invest in companies of any size, may hold cash, and may invest in fixed-income securities.

Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for long-term investors who want to gain exposure to Southeast Asian companies, and can handle the volatility of returns generally associated with equity investments. Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns. To invest in the Fund, investors should be willing to accept a medium to high level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

Results of Operations

Fidelity Far East Class, Series B, returned 26.6%, after fees and expenses, for the twelve-month period ended November 30, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI World Index, returned 32.0% (in Canadian dollar terms).

Market overview:

Global equities, as broadly measured by the MSCI World Index, returned 32.0% in Canadian dollar terms and 27.8% in U.S. dollar terms, for the one-year period ended November 30, 2024.

Global equities advanced for the period under review. Falling interest rates in major developed markets, decreasing inflation, and positive U.S. economic data, helped support investor confidence. Investor optimism in the digital innovation and artificial intelligence space helped fuel growth in the information technology and communication services sectors, propelling the technology-heavy NASDAQ Index to record highs. However, investor sentiment shifted later in the review period due to concerns about stretched valuations and relatively weaker U.S. economic growth. Valuations of companies in the financials sector rose, signalling optimism about potential earnings growth from reduced borrowing costs. Defensive sectors, such as utilities and consumer staples, also gained as investors looked for stability amidst ongoing market volatility. In Europe, equities surged despite some volatility along the way. Markets recovered as the European Central Bank implemented rate cuts, and China's central bank embarked on its most significant stimulus since the pandemic, in effort to ease the deflationary cycle. Japanese equities experienced volatility, amid shifting monetary policy expectations. The interest rate hike by the Bank of Japan led to a rapid unwinding of leveraged global trades, which created market volatility.

Factors affecting performance:

The Fund underperformed its broad-based benchmark, the MSCI World Index, primarily due to the Underlying Fund's investments in the health care and financials sectors. The Fund's benchmark, the MSCI AC (All Country) Far East ex Japan Index, returned 18.1% for the review period. The Fund outperformed its benchmark, primarily due to the Underlying Fund's exposure to certain stocks in the communication services and consumer discretionary sectors. In the communication services sector, an investment in Singapore-based internet company Sea Limited, and lack of exposure to a China-based internet and game services provider, contributed to relative returns. In the consumer discretionary sectors, an investment in India-based online travel firm MakeMyTrip, and India-based restaurant aggregator and food delivery firm Zomato, both contributed to relative returns. In other sectors, an investment in U.S.-based semiconductor firm NVIDIA contributed to relative returns.

In contrast, investments in, and higher-than-benchmark exposure to, the health care sector detracted from relative returns. In the sector, investments in China-based pharmaceutical firms WuXi AppTec and WuXi Biologics detracted from relative returns. Lower-than-benchmark exposure to, and investments in, the financials sector also detracted from relative returns. In this sector, an investment in South Korea-based IT service management firm Kakao Pay, and lack of exposure to a Singapore-based banking and financial services firm, detracted from relative returns. In other sectors, an investment in China-based retailing platform operator PDD Holdings, and lack of exposure to a Taiwan-based electrical components manufacturer, detracted from relative returns.

At the end of the review period, the Underlying Fund had no exposure to NVIDIA, WuXi Biologics or Kakao Pay. Portfolio changes:

During the review period, the Underlying Fund's exposure to the communication services and industrials sectors was increased. In the communication services sector, the portfolio manager

increased exposure to Sea Limited. In the industrials sector, a position was initiated in China-based battery products manufacturing firm Contemporary Amperex Technology. The portfolio manager believes these companies have good investment growth potential.

In contrast, exposure to the health care and information technology sectors was decreased as the portfolio manager pursued opportunities elsewhere with more perceived investment growth potential. In the health care sector, the portfolio manager reduced exposure to WuXi AppTec. In the information technology sector, exposure was reduced to South Korea-based electronics firm Samsung Electronics.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the information technology sector, followed by the consumer discretionary sector. The Underlying Fund diverged most from its benchmark's sector weightings by having more exposure to the consumer discretionary sector and less exposure to the financials sector.

Recent Developments

Portfolio manager Xiaoting Zhao is optimistic about the long-term growth prospects of the Far East region, and is always on the lookout for companies that appear to be underappreciated by the market. Following the recent market pullback in China, the manager has been seeking to build long-term positions in stocks that appear attractively valued in many of the new-economy segments. The portfolio manager believes that over the long term, a disciplined approach to the Fund's growth-oriented investment process may lead to limited downside risk and, eventually, better performance.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$741,000 for the period ended November 30, 2024.

Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$101,000 for the period ended November 30, 2024.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate is not necessarily a short sale in the value of purchases of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.






