## **Management Discussion of Fund Performance**

## **Investment Objective and Strategies**

Investment Objective: Fidelity Global Concentrated Equity Fund (Fund) aims to achieve long-term capital growth by investing primarily in equity securities of companies anywhere in the world.

Strategies: When buying and selling equity securities for the Fund, the portfolio manager examines a company's potential for success in light of its current financial condition, earnings estimates, quality of management, and industry position, as well as economic and market conditions. The portfolio manager aims to favour companies that show the potential for above-average earnings or growth. The Fund may invest in companies of any size.

## Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for medium- to long-term investors who want to gain global equity exposure, and can handle the volatility of returns generally associated with equity investments. The Fund is not an appropriate investment for investors with a short-term investment horizon. To invest in the Fund, investors should be willing to accept a medium level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

## **Results of Operations**

Fidelity Global Concentrated Equity Fund, Series B, returned 13.5%, after fees and expenses, for the one-year period ended March 31, 2024. The net returns of the other series of this Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI ACWI (All Country World Index) Index, returned 23.2% (in Canadian dollar terms).

#### Market overview:

Global equities, as broadly measured by the MSCI ACWI (All Country World Index), returned 23.2% in Canadian dollar terms and 23.2% in U.S. dollar terms, for the one-year period ended March 31, 2024.

Global equities advanced during the review period, as economic expansion, and the slowing pace of inflation in some countries provided a mostly favourable backdrop. Following continued tightening of monetary policies in major developed market economies throughout 2022 and for most of 2023, investor sentiment shifted in the fourth quarter of 2023 to a view that interest rates had peaked, and policymakers may cut rates in 2024. Equity market gains were partly fueled by select firms within the information technology and communication services sectors in the U.S., largely due to market exuberance surrounding artificial intelligence. In Europe, several large-capitalisation companies across the luxury goods, pharmaceuticals, and technology sectors supported equity markets. Japanese equities also rose, supported by decline in the value of the yen which aided exports, as well as due to corporate governance reforms that have boosted shareholder returns through increased share buybacks and dividends. From a regional perspective, while some global equity markets advanced to hit all-time highs, investors were more cautious towards Chinese equities due to the country's weaker than expected economic growth amid uncertainty surrounding the health of its property and banking sectors.

#### Factors affecting performance:

The Fund underperformed its benchmark, primarily due to investments in certain stocks in the consumer discretionary sector. In the sector, investments in China-based online retail firm Alibaba Group, and Netherlands-based investment firm Prosus, detracted from relative returns. In addition, lower-than-benchmark exposure to the information technology sector detracted from relative returns. In this sector, lack of exposure to a U.S.-based semiconductors firm, and an investment in Switzerland-based software firm Temenos AG, detracted from relative returns.

In contrast, exposure to certain stocks in the materials sector contributed to relative performance. In the sector, an investment in Canada-based mining firm Lundin Mining, and lack of exposure to a Australia-based mining firm, contributed to relative returns. In addition, exposure to certain stocks in the financials sector contributed to relative performance. In that sector, an investment in Spain-based banking firm BBVA, and out-of-benchmark exposure to Kazakhstan-based financial services firm Kaspi.kz AO, contributed to relative returns.

#### Portfolio changes:

During the review period, the Fund's exposure to the health care and materials sectors increased. In the health care sector, the portfolio manager initiated a position in Switzerland-based pharmaceuticals firm Roche Holding. In the materials sector, a position was initiated in U.S.-based chemicals firm International Flavors & Fragrance. The portfolio manager believes these companies have better-than-average investment growth potential.

In contrast, exposure to the industrials and information technology sectors decreased as the portfolio manager found, in their view, investment growth opportunities with more potential elsewhere. In the industrials sector, the portfolio manager exited a position in U.S.-based capital goods firm General Electric. In the information technology sector, a position was exited in U.S.-based software and services firm Verisign.

At the end of the review period, the Fund had its largest absolute exposure to the industrials sector and the consumer discretionary sector. The Fund diverged most from its benchmark's sector weightings by having more exposure to the industrials sector and less exposure to the information technology sector.

## **Recent Developments**

Portfolio manager Patrice Quirion continues to take a long-term approach to investing and focuses on companies with sustainable quality, in their view. The portfolio manager favours companies that are demonstrating steady and predictable growth. The portfolio manager seeks global leaders, multinationals and high-quality companies that exhibit attractive risk/return characteristics over the long term, in their view. The portfolio manager is also looking for companies that have characteristics similar to those of leading multinationals, but may be global leaders in niche areas.

Effective September 19, 2023, Anne Bell of Mississauga, Ontario, became a member of the Independent Review Committee (IRC).

## **Related Party Transactions**

#### **Manager and Portfolio Adviser**

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity provides investment advice with respect to the Fund's investment portfolio and arranges for the acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$6,439,000 for the period ended March 31, 2024.

#### Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$685,000 for the period ended March 31, 2024.

#### **Brokerage Commissions**

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non-affiliated, qualified brokerage firms, on an execution-only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$0 for the period ended March 31, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

#### Independent Review Committee, Cross-Trading and In specie Transactions

#### Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

## **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

## **Management and Advisory Fees**

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.




