## **Management Discussion of Fund Performance**

#### **Investment Objective and Strategies**

Investment Objective: Fidelity Global Innovators ® Currency Neutral Class (Fund) aims to achieve long-term capital appreciation and invests substantially all of its assets in securities of Fidelity Global Innovators ® Investment Trust (Underlying Fund). The Underlying Fund aims to achieve long term capital appreciation by investing primarily in equity securities of companies located anywhere in the world that have the potential to be disruptive innovators. The Underlying Fund seeks to identify companies that are positioned to benefit from the application of innovative and emerging technology, or that employ innovative business models. The Fund uses derivatives to try to minimize exposure to currency fluctuations between foreign currencies in developed markets (such as the U.S. dollar, the euro or the yen) and the Canadian dollar. The Fund may also hedge against other foreign currencies.

Strategies: The portfolio manager of the Underlying Fund aims to identify companies that have the potential to be disruptive in their industries. These types of companies may, among other things, attempt to: (i) develop or produce innovative technologies; (ii) use new technology in order to displace established markets, methods, industries, or technologies; (iii) become leaders in new and emerging industries; or (iv) use innovative business models, processes or technologies to gain a competitive edge. When buying and selling securities for the Underlying Fund, the portfolio manager examines each company's potential for success in light of its current financial condition and industry position, as well as economic and market conditions. The portfolio manager considers factors like growth potential, earnings estimates, cash flow and quality of management. The Underlying Fund may invest in companies of any size. The Underlying Fund may sometimes have significant exposure to relatively few companies and industries.

#### Risk

The risks associated with investing in this Fund remain as discussed in the prospectus. Any changes to the Fund over the period have not affected the overall level of risk of the Fund.

The Fund is suitable for medium- to long-term investors who want to gain exposure to companies anywhere in the world that have the potential to be disruptive innovators while seeking to lower their risk of currency fluctuations between developed market foreign currencies and the Canadian dollar, and can handle the volatility of returns generally associated with equity investments. Registered plan investors should be aware that the Fund may, from time to time, bear an income tax expense which will reduce returns. To invest in the Fund, investors should be willing to accept a high level of risk. The suitability of the investment has not changed from what has been disclosed in the prospectus.

#### **Results of Operations**

Fidelity Global Innovators ® Currency Neutral Class, Series B, returned 56.4%, after fees and expenses, for the twelve-month period ended November 30, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI All Country World Index - Hedged CAD, returned 26.8% (in Canadian dollar terms).

#### Market overview:

Global equities, as broadly measured by the MSCI All Country World Index, returned 30.2% in Canadian dollar terms and 26.1% in U.S. dollar terms, for the one-year period ended November 30, 2024.

Global equities advanced for the period under review. Falling interest rates in major developed markets, decreasing inflation, and positive U.S. economic data, helped support investor confidence. Investor optimism in the digital innovation and artificial intelligence space helped fuel growth in the information technology and communication services sectors, propelling the technology-heavy NASDAQ Index to record highs. However, investor sentiment shifted later in the review period due to concerns about stretched valuations and relatively weaker U.S. economic growth. Valuations of companies in the financials sector rose, signalling optimism about potential earnings growth from reduced borrowing costs. Defensive sectors, such as utilities and consumer staples, also gained as investors looked for stability amidst ongoing market volatility. In Europe, equities surged despite some volatility along the way. Markets recovered as the European Central Bank implemented rate cuts, and China's central bank embarked on its most significant stimulus since the pandemic, in effort to ease the deflationary cycle. Japanese equities experienced volatility, amid shifting monetary policy expectations. The interest rate hike by the Bank of Japan led to a rapid unwinding of leveraged global trades, which created market volatility. Emerging markets rose but lagged developed markets. Sentiment towards emerging market equities improved towards the end of the periods, after the U.S. Federal Reserve's announcement of a rate cut and China's stimulus measures supported a more optimistic growth outlook for the region.

#### Factors affecting performance:

The Fund outperformed its broad-based benchmark, the MSCI All Country World Index - Hedged CAD. The Underlying Fund's security selection in and higher-than-benchmark exposure to the information technology sector, as well as security selection in the industrials sector, contributed to relative returns.

The Fund's benchmark, the NASDAQ Composite Index - Hedged CAD, returned 33.8% for the review period. The Fund outperformed its benchmark, primarily due to the Underlying Fund's investments in the information technology sector, where a higher-than-benchmark allocation to U.S.-based semiconductors company NVIDIA and an investment in U.S.-based mobile technology company AppLovin contributed to relative returns. Investments in the industrials sector, such as U.S.-based critical infrastructure technology company Vertiv and U.S.-based electrical and mechanical construction company Emcor Group, also contributed to relative returns. In other sectors, investments in U.S.-based cryptocurrency exchange platform Coinbase Global and U.S.-based multinational social technology company Meta contributed to relative returns.

In contrast, a higher-than-benchmark exposure to energy sector detracted from relative returns, particularly out-of-benchmark exposure to Canada-based uranium company Cameco and U.S.-based mining and exploration company Uranium Energy. A lower-than-benchmark exposure to, and investments in, the communication services sector also detracted from relative returns. In this sector, an out-of-benchmark exposure to U.S.-based social media services firm Pinterest and a lower-than-benchmark exposure to U.S.-based streaming media company Netflix detracted from relative returns. Among other sectors, investments in U.S.-based pharmaceuticals and biotechnology firm Moderna, and U.S.-based semiconductor company Broadcom also detracted from relative returns.

At the end of the review period, the Underlying Fund had no exposure to Vertiv Holdings, Emcor Group, Uranium Energy, Netflix or Moderna.

#### Portfolio changes:

During the review period, the Underlying Fund's exposure to the consumer staples and financials sectors was increased. In the consumer staples sector, the portfolio manager initiated a position in U.S.-based membership-only warehouse club retail chain Costco Wholesale. In the financials sector, a position was initiated in U.S.-based financial services company Robinhood Markets. The portfolio manager believes these companies have a relatively more attractive risk/reward potential.

In contrast, exposure to the industrials and energy sectors was decreased; the portfolio manager sought investment opportunities elsewhere with more attractive growth potential. In the industrials sector, the portfolio manager exited a position in Vertiv. In the energy sector, exposure was reduced to Cameco.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the information technology sector, followed by the communication services sector. The Underlying Fund diverged most from its benchmark's sector weightings by having more exposure to the financials sector and less exposure to the information technology sector.

#### Derivatives disclosure:

During the period, the Fund engaged in forward foreign currency contracts, in a manner consistent with its investment objectives and strategies, to hedge against the effect of currency fluctuations on the investment returns of the Fund. The use of forward contracts in this manner does not completely eliminate the impact of currency fluctuations on returns and the Fund's returns will differ from the local currency returns of the Underlying Fund's investments.

#### **Recent Developments**

Portfolio manager Mark Schmehl's investment approach focuses on identifying what are believed to be positive changes in company fundamentals. The portfolio manager seeks to add value by uncovering investment opportunities where the portfolio manager believes business conditions are or could be improving. In the manager's view, the current market backdrop is constructive, with a soft landing in the U.S. having become a more probable outcome, given the continued resiliency of the U.S. economy. The manager has been seeking to identify out-of-favour stocks, as well as opportunities across different sectors in areas that are expected to benefit from growth tailwinds.

#### **Related Party Transactions**

#### **Manager and Portfolio Adviser**

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$15,613,000 for the period ended November 30, 2024.

#### **Administration Fee**

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$2,445,000 for the period ended November 30, 2024.

#### Independent Review Committee, Cross-Trading and In specie Transactions

#### Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

#### **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI

81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

#### **Management and Advisory Fees**

Fidelity serves as manager and investment advisor of the Fund. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.








