Management Discussion of Fund Performance

Results of Operations

Fidelity Canadian Equity Private Pool (Fund) invests substantially all of its assets in securities of Fidelity Canadian Equity Multi-Asset Base Fund (Underlying Fund).

Fidelity Canadian Equity Private Pool, Series B, returned 9.7%, after fees and expenses, for the six-month period ended May 31, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, Canadian equities, as represented by the S&P/TSX Composite Index, returned 11.8% (in Canadian dollar terms).

Market overview:

Canadian equities, as measured by the S&P/TSX Composite Index, returned 11.8%, for the six-months period ended May 31, 2024.

Canadian equities advanced for the period under review. Robust gains in the materials sector due to rising gold and commodity prices, as well as the broader rise in cyclically sensitive sectors, such as energy and financials supported performance. In contrast, the communication services and information technology sectors came under pressure, particularly towards the end of the review period. A stable domestic economic environment, resilient growth in the U.S. economy, combined with a general trend towards lower inflation supported investor sentiment. The Canadian banking sector generally remained healthy, despite modest signs of stress among smaller businesses and households. The annual inflation rate fell to 2.7% in April 2024 from 2.9% in March 2024, due to slower growth of food prices. In the labour market, the unemployment rate remains unchanged at 6.1% in April from its two-year high. The Bank of Canada (BoC) forecasts GDP growth of 1.5% in 2024 and 2.2% in 2025. Based on the outlook, the BoC lowered its policy rate by 25-basis points in June 2024 to 4.75%, the first rate cut in four years.

Factors affecting performance:

The Fund's benchmark, the S&P/TSX Capped Composite Index, returned 11.8% for the period under review. The Fund underperformed its benchmark, primarily due to the Underlying Fund's investments in, and lower-than-benchmark exposure to, the financials and materials sectors. In the financials sector, lower-than-benchmark exposure to Canada-based insurance firm Manulife Financial, and lack of exposure to a Canada-based banking firm, detracted from relative returns. In the materials sector, lower-than-benchmark exposure to Canada-based gold mining firm Barrick Gold, and lack of exposure to a Canada-based base metals mining firm, also detracted from relative returns. In other sectors, an investment in Canada-based telecommunications firm Rogers Communications, and lower-than-benchmark exposure to Canada-based integrated energy company Suncor Energy, both detracted from relative returns.

In contrast, exposure to certain stocks in the consumer discretionary and information technology sectors contributed to relative returns. In the consumer discretionary sector, an investment in Canada-based retail chain Dollarama, and lower-than-benchmark exposure to Canada-based fast food holding firm Restaurant Brands International, contributed to relative returns. In the information technology sector, lower-than-benchmark exposure to Canada-based e-commerce firm Shopify, and an investment in Canada-based software firm Constellation Software, both contributed to relative returns. In other sectors, investments in Canada-based media firm Thomson Reuters, and Canada-based gold mining firm Agnico Eagle Mines, contributed to relative returns.

At the end of the review period, the Underlying Fund had no exposure to Restaurant Brands International.

Portfolio changes:

During the review period, the Underlying Fund's exposure to the financials and utilities sectors was increased. In the financials sector, the portfolio manager initiated a position in Canada-based insurance firm Manulife Financial. In the utilities sector, exposure was increased to Canada-based electric and gas utility firm Fortis Inc. The portfolio manager believes these companies have good investment growth potential.

In contrast, exposure to the communication services and consumer discretionary sectors was decreased, as the portfolio manager sought investment growth opportunities elsewhere. In the communication services sector, the portfolio manager reduced exposure to Canada-based telecommunications firm BCE Inc. In the consumer discretionary sector, the portfolio manager reduced exposure to Canada-based telecommunications firm BCE Inc. At the end of the review period, the Underlying Fund had its largest absolute exposure to the financials sector, followed by the energy sector. The Underlying Fund diverged most from its benchmark's sector weightings by having more exposure to the information technology sector and less exposure to the energy sector.

Recent Developments

Portfolio manager Andrew Marchese believes there is a high level of uncertainty in the market. The portfolio manager also believes there have been unprecedented shocks in the market, presenting challenges for many companies. In the portfolio manager's opinion, as economic activities continue to normalize, markets will likely be less influenced by macroeconomic factors and driven more by the earnings of individual companies. Against this backdrop, the portfolio manager and the investment team are focusing on companies they believe to have strong balance sheets. Macroeconomic analysis will continue to be reviewed against company fundamentals, with a focus on adding value by selecting companies they believe exhibit attractive growth potential, strong management, and favourable risk/reward profiles.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity provides investment advice with respect to the Fund's investment portfolio and arranges for the acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$527,000 for the period ended May 31, 2024.

Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$57,000 for the period ended May 31, 2024.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.








