Management Discussion of Fund Performance

Results of Operations

Securities of this Fund are only available for purchase by other funds and accounts managed or advised by Fidelity, and are not available for public purchase.

Fidelity Convertible Securities Multi-Asset Base Fund (Fund), Series O, returned 15.8%, for the six-month period ended December 31, 2024. During the review period, U.S. fixed income, as represented by the Bloomberg U.S. Aggregate Bond Index, returned 7.2% (in Canadian dollar terms).

Market overview:

U.S. investment-grade bonds, as broadly represented by the Bloomberg U.S. Aggregate Bond Index, returned 7.2% in Canadian dollar terms and 2.0% in U.S. dollar terms, for the six-month period ended December 31, 2024.

U.S. investment-grade bonds advanced in Canadian and U.S. dollar terms during the period under review. High yield bonds continued to outperform their investment-grade peers, benefiting from higher yields and tighter credit spreads. Any decreases to headline inflation at the outset of the period were reversed in the later months of the year, with headline inflation increasing to 2.9% in December 2024. The U.S. Federal Reserve (the Fed) commenced their easing cycle with a 50-basis point cut in September followed by a 25-basis point cut in November and December. The U.S. 10-year Treasury yield remained volatile and rose towards the end of the review period. This was driven by strong economic data and the concern that, regardless of the election results, the new administration would increase U.S. Treasury issuance to fund a growing budget deficit. The unemployment rate remained at 4.1% in December 2024, unchanged since June 2024, while a separate report showed a sharp increase in the number of job openings and higher employment growth at the end of the review period, reinforcing the view that the labour market remains largely strong.

Factors affecting performance:

The Fund's benchmark, the ICE BofA All U.S. Convertibles Index, returned 14.4% for the period under review. The Fund outperformed its benchmark, primarily due to its investments in the industrials and consumer discretionary sectors. In the industrials sector, investments in U.S.-based end-to-end space company Rocket Lab, and U.S.-based public safety technology Axon Enterprise, contributed to relative returns. In consumer discretionary sector, an investment in U.S.-based cruise operator and leisure travel company Carnival Corporation, and lower-than-benchmark exposure to U.S.-based e-commerce company Wayfair, also contributed to relative returns. In other sectors, an investment in U.S.-based business intelligence company MicroStrategy, and out-of-benchmark exposure to Canada-based electricity generation company TransAlta Corp., both contributed to relative returns.

In contrast, investments in the energy and materials sectors detracted from relative returns. In the energy sector, out-of-benchmark exposure to Bermuda-based crude oil tanker company DHT Holdings, and to Bermuda-based shipping company Frontline, detracted from relative returns. In the materials sector, lower-than-benchmark exposure to U.S.-based recycling services provider PureCycle Technologies, and out-of-benchmark exposure to Canada-based mining company Equinox Gold Corp., also detracted from relative returns. In other sectors, an investment in U.S.-based semiconductor products manufacturer Wolfspeed, and out-of-benchmark exposure to Monaco-based tanker shipping company Scorpio Tankers, both detracted from relative returns.

At the end of the review period, the Fund had no exposure to Equinox Gold Corp.

Portfolio changes:

During the review period, the Fund's exposure to the information technology and industrials sectors was increased. In the information technology sector, the portfolio managers initiated a position in MicroStrategy. In the industrials sector, a position was initiated in U.S.-based aerospace company Boeing. The portfolio managers believe these companies have good investment growth potential.

In contrast, the Fund's exposure to the utilities and materials sectors was reduced. In the utilities sector, exposure was reduced to FirstEnergy. In the materials sector, the portfolio manager exited a position in U.S.-based specialty materials company ATI. The portfolio manager sought investment opportunities in other sectors that appeared to have better upside potential.

At the end of the review period, the Fund had its largest absolute exposure to the information technology sector, followed by the industrials sector. The Fund diverged most from its benchmark's sector weightings by having more exposure to the information technology sector and less exposure to the financials sector.

Recent Developments

Looking ahead, portfolio managers Adam Kramer and Rick Gandhi will diligently assess market conditions, seeking market segments and specific securities that have been substantially mispriced. The portfolio managers' goal is to uncover opportunities that, in the managers' view, have the potential to deliver equity-like returns during favourable market conditions, coupled with reduced volatility and enhanced capital preservation. The portfolio managers stand ready to adapt the portfolio swiftly as opportunities arise.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day-to-day operations, bookkeeping, record-keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund is only offered in Series O securities and is only available to: (i) institutional investors who may be individuals or financial institutions who have been approved by Fidelity and have entered into Series O fund purchase agreements with Fidelity; or (ii) other funds and accounts managed or advised by Fidelity. The Fund does not pay management and advisory fees, or other operating expenses, other than certain specified fund costs, including taxes, brokerage commissions and interest charges.

Brokerage Commissions

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non-affiliated, qualified brokerage firms, on an execution-only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$2,000 for the period ended December 31, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

^G The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate includes any proceeds from a short sale in the value of sales of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

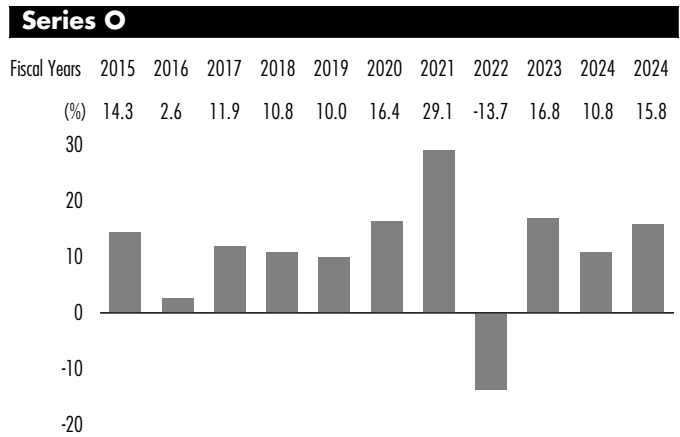
