Management Discussion of Fund Performance

Results of Operations

Securities of this Fund are only available for purchase by other funds and accounts managed or advised by Fidelity, and are not available for public purchase.

Fidelity Founders Investment Trust. Series 0, returned 7.7%, for the six-month period ended September 30, 2024, During the review period, U.S. equities, as represented by the Russell 3000 Index, returned 9.5% (in Canadian dollar terms).

Market overview:

U.S. equities, as measured by the S&P 500 Index, returned 10.2% in Canadian dollar terms and 10.4% in U.S. dollar terms, for the six-month period ended September 30, 2024.

U.S. equities rose over the review period. Despite significant volatility over the period under review, the U.S. equity market finished higher due to a strong economy, positive earnings growth, and expectations of easing inflation. The information technology and communication services sectors were an area of strength early in the review period, but later experienced volatility partly due to investor skepticism regarding the future returns from investments in artificial intelligence. The U.S. Federal Reserve's (the Fed) preferred measure of inflation, the annual core personal consumption expenditures index, fell to 2.7% in August 2024 from 2.8% in April 2024, while the annual consumer-price index eased to 2.5% in August, the lowest since February 2021. The U.S. economy added 159,000 jobs in August, while the unemployment rate increased to 4.2% in August 2024 from 3.9% in April 2024. Against this backdrop, the Fed approved its first interest rate cut in four years in September 2024, reducing the benchmark policy rate by 50 basis points to 4.75–5.0%.

Factors affecting performance:

The Fund underperformed its benchmark, the Russell 3000 Index, primarily due to positioning in the information technology sector. In the sector, a lack of exposure to a U.S.-based technology hardware and equipment firm, and an investment in U.S.-based software and services firm MicroStrategy, detracted from relative returns. Investments in, and higher-than-benchmark exposure to, the consumer discretionary sector also detracted from relative returns, particularly investments in U.S.-based consumer services firm Airbnb, and U.S.-based digital sports entertainment and gaming company DraftKings Holdings. In other sectors, an investment in U.S.-based energy equipment and solutions firm Nextracker, detracted from relative returns.

In contrast, exposure to certain stocks in the communication services sector contributed to relative returns. In the sector, an investment in U.S.-based media and entertainment firm Meta, and a lack of exposure to a U.S.-based media and entertainment firm, contributed to relative returns. Exposure to certain stocks in the real estate sector also contributed to relative returns. In the sector, a higher-than-benchmark exposure to U.S.-based self-storage company Public Storage and U.S.-based real estate marketplace company Zillow Group, contributed to relative returns. In other sectors, investments in U.S.-based semiconductor firm NVIDIA, U.S.-based software and services firm Oracle, and U.S.-based biopharmaceutical firm Alnylam Pharmaceuticals, contributed to relative returns.

At the end of the review period, the Fund had no exposure to DraftKings Holdings.

Portfolio chanaes:

During the review period, the Fund's exposure to the real estate and consumer discretionary sectors was increased. In the real estate sector, the portfolio manager increased exposure to Public Storage. In the consumer discretionary sector, exposure was increased to U.S.-based home construction firm D.R. Horton. The portfolio manager believes that these companies have good investment growth potential.

In contrast, exposure to the information technology and energy sectors was decreased; the portfolio manager sought better investment arowth opportunities elsewhere. In the information technology sector, the portfolio manager reduced exposure to MicroStrategy. In the energy sector, a position in U.S.-based oil and gas exploration and production firm Hess Corporation was exited.

At the end of the review period, the Fund had its largest absolute exposure to the information technology sector, followed by the consumer discretionary sector. The Fund diverged most from its benchmark sector weightings by having more exposure to the consumer discretionary sector and less exposure to the consumer staples sector.

Recent Developments

Portfolio manager Daniel Kelley is increasingly optimistic about improving fundamentals in a wide variety of sectors, despite relatively elevated macroeconomic uncertainty for the better part of the last three years. The portfolio manager remains focused on the importance of broadening market strength. The portfolio manager believes that the increased interest in new investment ideas related to AI adoption has expanded the array of investable themes for the overall market. The portfolio manager is sharpening the focus on founder-involved companies with astute leaders who, in the manager's view, are exercising capital discipline, cutting costs, raising prices, and finding innovative ways to drive sustainable revenue. The portfolio manager is especially interested in founder-involved companies that have seen their earnings expand relative to their industry peers, and price-to-earnings valuations drop organically as a result. The portfolio manager believes founder-involved companies that have used the high-interest-rate environment to strengthen their business models have the highest likelihood of becoming more profitable and driving new revenue streams. Across sectors, the portfolio manager is still focused on founder-involved companies which, in the manager's view, can generate durable and consistent earnings growth.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund is only offered in Series O securities and is only available to: (i) institutional investors who may be individuals or financial institutions who have been approved by Fidelity and have entered into Series O fund purchase agreements with Fidelity; or (ii) other funds and accounts managed or advised by Fidelity. The Fund does not pay management and advisory fees, or other operating expenses, other than certain specified fund costs, including taxes, brokerage commissions and interest charges.

Brokerage Commissions

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non-affiliated, qualified brokerage firms, on an execution-only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$2,000 for the period ended September 30, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.


⁶ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund selling all of the securities in its portfolio acce in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate is nonuclized. The portfolio turnover rate excludes any adjustment for in-kind transactions.
