#### **Management Discussion of Fund Performance**

#### **Results of Operations**

Fidelity U.S. Focused Stock Fund (Fund), Series B, returned 9.7%, after fees and expenses, for the six-month period ended December 31, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, U.S. equities, as represented by the S&P 500 Index, returned 14.0% (in Canadian dollar terms).

Market overview:

U.S. equities, as measured by the S&P 500 Index, returned 14.0% in Canadian dollar terms and 8.4% in U.S. dollar terms, for the six-month period ended December 31, 2024.

U.S. equities rose over the review period as expectations of monetary policy easing and continued corporate earnings growth supported investor sentiment. An anticipation of further tax cuts, expansionary fiscal policy, and possibilities of a protectionist trade stance further supported equity markets. The consumer discretionary and financials sectors gained the most from these developments. Additionally, cyclical sectors, including real estate and industrials, also generated positive returns. Investor optimism in the artificial intelligence initially boosted gains in the information technology and communication services sectors but faced volatility in the latter part of the review period due to concerns about stretched valuations. Defensive sectors, such as utilities and consumer staples, also gained as investors looked for stability amidst ongoing market volatility. The U.S. economy exhibited healthy growth, expanding by an annualized rate of 2.8% in the third quarter, supported by robust consumer and government spending. However, geopolitical risks, mixed economic signals in the U.S., and the U.S. Federal Reserve's (the Fed) adoption of a more cautious approach to its monetary policy easing cycle introduced some volatility. Over the period under review, the Fed reduced its benchmark interest rate (the Fed Funds Rate) thrice in subsequent meetings, from 5.5% to 5.0% in the September meeting, from 5.0% to 4.75% in the November meeting, and from 4.75% to 4.5% in the December meeting. U.S. inflation, as measured by the consumer price index, increased to 2.9% in December 2024, however headline inflation remains lower than the reported 3.0% in June 2024.

#### Factors affecting performance:

The Fund underperformed its benchmark, the S&P 500 Index, primarily due to investments in certain stocks in the industrials sector. In this sector, out-of-benchmark exposure to U.S.-based critical infrastructure solutions company Vertiv Holdings and U.S.-based engineering and technology solutions provider KBR detracted from relative returns. In addition, investments in, and lower-than-benchmark exposure to, the information technology sector detracted from relative returns. In this sector, investments in U.S.-based semiconductor firms Micron Technology and NVIDIA detracted from relative returns. In other sectors, an investment in U.S.-based pharmaceutical firm Eli Lilly and out-of-benchmark exposure to U.S.-based natural gas and liquids company Antero Resources and U.S.-based cryptocurrency exchange platform company Coinbase Global detracted from relative returns.

In contrast, exposure to certain stocks in the utilities sector contributed to relative returns. In this sector, an investment in U.S.-based energy firm Constellation Energy contributed to relative returns. In addition, a higher-than-benchmark exposure to the consumer discretionary sector contributed to relative returns. In this sector, out-of-benchmark exposure to U.S.-based used car dealer Carvana and U.S.-based thermal management company Modine Manufacturing contributed to relative returns. In other sectors, investments in U.S.-based motion and control technologies firm Parker Hannifin and U.S.-based financial services firm Fiserv contributed to relative returns.

At the end of the review period, the Fund had no exposure to Vertiv Holdings, Micron Technology, Antero Resources or Coinbase Global.

#### Portfolio changes:

During the review period, the Fund's exposure to the financials and consumer discretionary sectors was increased. In the financials sector, the portfolio manager initiated a position in U.S.-based bank holding company M&T Bank. In the consumer discretionary sector, a position was initiated in U.S.-based automotive and clean energy firm Tesla. The portfolio manager believes these companies have good investment growth potential.

In contrast, exposure to the information technology and health care sectors was decreased. In the information technology sector, the portfolio manager reduced exposure to U.S.-based technology firm Apple. In the health care sector, a position was exited from Denmark-based pharmaceutical firm Novo Nordisk.

At the end of the review period, the Fund had its largest absolute exposure to the information technology sector, followed by the consumer discretionary sector. The Fund diverged most from its benchmark's sector weightings by having more exposure to the consumer discretionary sector and less exposure to the information technology sector.

#### **Recent Developments**

Portfolio manager Stephen DuFour manages a concentrated portfolio, investing in companies the portfolio manager believes will, over time, offer growth at reasonable prices. The portfolio manager seeks investments that the manager believes could grow earnings materially faster than the market, and that are still trading at attractive valuations. Sector and industry positioning is a result of the portfolio manager's best fundamental bottom-up ideas rather than top-down sector calls. The portfolio manager has an optimistic long-term view on U.S. markets as new technologies continue to emerge and believes disruption in various industries may continue to offer great opportunities. The portfolio manager continues to believe the market environment is ripe for stock selection and emphasizes the potential for increased prices driven by quality earnings growth and expanding multiples, especially as macro headwinds alleviate, earnings continue to strengthen in 2025, and new innovative ideas continue to increase corporate efficiencies.

On September 6, 2024, Fidelity U.S. Focused Stock Systematic Currency Hedged Fund merged into the Fund.

#### **Related Party Transactions**

#### Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$11,423,000 for the period ended December 31, 2024.

#### **Administration Fee**

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$1,109,000 for the period ended December 31, 2024.

#### **Brokerage Commissions**

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non—affiliated, qualified brokerage firms, on an execution—only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$35,000 for the period ended December 31, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

#### Independent Review Committee, Cross-Trading and In specie Transactions

#### **Independent Review Committee**

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

#### **Cross-Trading and In specie Transactions**

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

#### **Management and Advisory Fees**

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.




