Management Discussion of Fund Performance

Results of Operations

Securities of this Fund are only available for purchase by other funds and accounts managed or advised by Fidelity, and are not available for public purchase.

Fidelity Global Dividend Investment Trust, Series O, returned 8.5%, for the six-month period ended September 30, 2024. During the review period, global equities, as represented by the MSCI All Country World Index, returned 9.5% (in Canadian dollar terms).

Market overview:

Global equities, as broadly measured by the MSCI All Country World Index, returned 9.5% in Canadian dollar terms and 9.7% in U.S. dollar terms, for the six-month period ended September 30, 2024.

Global equities rose during the review period. Steady growth in the U.S. economy along with expectations that declining inflation may support further rate cuts across most developed markets, supported investor confidence. Investor optimism in the artificial intelligence initially boosted gains in the information technology and communication services sectors but faced volatility in the latter part of the review period due to skepticism about stretched valuations. Defensive sectors such as utilities and consumer staples gained, as investors looked for stability amidst ongoing market volatility. Interest rate sensitive sectors, including real estate and financials sectors also rose, indicating optimism about enhanced earnings potential due to lower borrowing costs for consumers and businesses. In Europe, strong corporate earnings and decelerating inflation supported investor confidence. The European Central Bank reduced its benchmark interest rates by 25 basis points in June and September, bringing the rate down to 3.50%. Japanese equities experienced a period of volatility amid rising concerns about a recession in the U.S., an unexpected rise in Bank of Japan's benchmark rate of interest and the rise in the value of yen against the U.S. dollar. Emerging markets rose but lagged developed markets amid concerns about the outlook for China's economy, despite a modest recovery in growth and supportive policy measures announced by the People's Bank of China.

Factors affecting performance:

The Fund underperformed its benchmark, primarily due to its investments in and underweight exposure to, certain non-dividend or very low-dividend paying stocks in the information technology sector, which made up the majority of detractors. In this sector, lack of exposure to U.S.-based semiconductors and semiconductor equipment firms detracted from relative returns. Investments in certain stocks in the consumer discretionary sector also detracted from relative returns. In this sector, lack of exposure to a U.S.-based automotive and green energy company, and an investment in France-based luxury goods company LVMH Moët Hennessy Louis Vuitton, both detracted from relative returns. In other sectors, investments in U.S.-based discount store company Dollar Tree and Germany-based automotive and defense manufacturer Rheinmetall detracted from relative returns.

In contrast, exposure to certain stocks in the health care sector, including Switzerland-based pharmaceutical company Roche Holding, along with a lack of exposure to a Netherlands-based multinational pharmaceutical company, contributed to relative returns. Exposure to certain stocks in the industrials sector, such as Japan-based multinational conglomerate Hitachi Limited and U.S.-based aerospace solutions provider General Aerospace, also contributed to relative returns. In other sectors, investments in U.S.-based retail electricity and power generation firm Vistra Corp., Taiwan-based semiconductors manufacturing company Taiwan Semiconductor Manufacturing Company and U.S.-based multinational consumer electronics company Apple all contributed to relative returns.

Portfolio changes:

During the review period, the portfolio manager increased exposure to the health care and utilities sectors. In the health care sector, the portfolio manager initiated a position in Italy-based pharmaceutical company Recordati. In the utilities sector, exposure was increased to Vistra Corp. The portfolio manager believes these companies have better-than-average investment growth potential.

In contrast, exposure to the financials and materials sectors was decreased, as the portfolio manager found what they viewed as better investment growth opportunities elsewhere. In the financials sector, the portfolio manager decreased the Funds' position in U.S.-based banking firm J.P. Morgan Chase. In the materials sector, exposure was reduced to U.S.-based mining company Freeport-McMoRan.

At the end of the review period, the Fund had its largest absolute exposure to the information technology sector and the financials sector. The Fund diverged most from its benchmark's sector weightings by having more exposure to the consumer staples sector and less exposure to the information technology sector.

Recent Developments

Global equities portfolio manager Ramona Persaud strives to achieve three investment goals: producing excess returns, providing downside protection, and generating a reasonable level of income. The portfolio manager seeks to capitalize on periods of uncertainty to upgrade the quality of the portfolio. More specifically, the portfolio manager has been looking for high-quality companies trading at attractive valuations due to negative sentiment, while selling stocks with valuations that appear extended, in their view. At the same time, the manager is also focused on protecting the portfolio against potential market volatility. As a result, the portfolio manager remains committed to maintaining a portfolio that has a high-quality bias, to help preserve investor capital during periods of market volatility.

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund is only offered in Series O securities and is only available to: (i) institutional investors who may be individuals or financial institutions who have been approved by Fidelity and have entered into Series O fund purchase agreements with Fidelity; or (ii) other funds and accounts managed or advised by Fidelity. The Fund does not pay management and advisory fees, or other operating expenses, other than certain specified fund costs, including taxes, brokerage commissions and interest charges.

Brokerage Commissions

The Fund may place a portion of its portfolio transactions with brokerage firms which are affiliates of Fidelity, provided it determines that these affiliates' trade execution abilities and costs are comparable to those of non-affiliated, qualified brokerage firms, on an execution-only basis. Commissions paid to brokerage firms that are affiliates of Fidelity Investments were \$10,000 for the period ended September 30, 2024. Fidelity receives standing instructions from the IRC in respect of policies and procedures governing best execution of transactions with affiliates, which includes brokers affiliated to Fidelity Investments, at least once per year.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.


⁶ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund selling all of the securities in its portfolio acce in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate is nonuclized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

Fidelity Global Dividend Investment Trust Past Performance
