Management Discussion of Fund Performance

Results of Operations

Fidelity Japan Class (Fund) invests substantially all of its assets in securities of Fidelity Japan Fund (Underlying Fund).

Fidelity Japan Class, Series B, returned 12.0%, after fees and expenses, for the six-month period ended May 31, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI World Index, returned 15.5% (in Canadian dollar terms).

Market overview:

Global equities, as broadly measured by the MSCI World Index, returned 15.5% in Canadian dollar terms and 14.9% in U.S. dollar terms, for the six-month period ended May 31, 2024.

Global equities advanced during the review period, as resilient economic data and expectations for interest rate cuts, fuelled by decelerating inflation in developed markets, supported expectations for a soft landing in the global economy. Better-than-expected corporate earnings growth further encouraged investor confidence. However, markets were volatile as inflation remained well above the target range of most developed market central banks. Against this global backdrop, U.S., Japan, and Europe ex-U.K. equities rose. In Europe, equities posted robust returns, supported by resilient economic and corporate data as well as a slew of dovish cues from major central banks. Japanese equities also rose, driven primarily by central bank policy expectations, centred on the Bank of Japan and the U.S. Federal Reserve, accompanied by weakness in the Yen. Emerging markets also ended higher but lagged developed markets amid concerns around China's sluggish economic recovery. Investors were concerned about China's growth prospects in the absence of any meaningful stimulus and a suppressed housing market.

Factors affecting performance:

The Fund's benchmark, the Tokyo Stock Price Index (TOPIX), returned 11.7% for the review period. The Fund outperformed its benchmark, primarily due to the Underlying Fund's exposure to certain stocks in the industrials and health care sectors. In the industrials sector, investments in Japan-based diversified industrial conglomerates Mitsubishi Heavy Industries and Hitachi contributed to relative returns. In the health care sectors, an investment in Japan-based pharmaceutical firm Daiichi Sankyo and a lack of exposure to a Japan-based pharmaceutical firm contributed to relative returns. In other sectors, investments in Japan-based banks financial holding firms Sumitomo Mitsui Financial Group and Mitsubishi UFJ Financial Group contributed to relative returns.

In contrast, investments in certain stocks in the information technology sector, such as Japan-based software testing firm SHIFT, along with a lack of exposure to a Japan-based semiconductor firm, detracted from relative returns. Investments in, and higher-than-benchmark exposure to, the consumer discretionary sector also detracted from relative returns, particularly investments in Japan-based consumer electronics firm Sony Group and Japan-based retail firm Fast Retailing. In other sectors, investments in Japan-based food firm Nissin Foods Holdings and Japan-based management consulting firm BayCurrent Consulting detracted from relative returns.

At the end of the review period, the Underlying Fund had no exposure to SHIFT or BayCurrent Consulting.

Portfolio changes:

During the review period, the Underlying Fund's exposure to the industrials and financials sectors was increased. In the industrials sector, the portfolio manager initiated a position in Japan-based electric motors manufacturer Nidec. In the financials sector, exposure was increased to Japan-based banks financial holding firm Mitsubishi UFJ Financial Group. The portfolio manager believes these companies have good investment growth potential.

In contrast, exposure to the consumer staples and information technology sectors was decreased, and the portfolio manager pursued investment growth opportunities elsewhere with more potential. In the consumer staples sector, the portfolio manager reduced exposure to Japan-based food firm Nissin Foods Holdings. In the information technology sector, a position in Japan-based software testing firm SHIFT was sold off.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the industrials sector, followed by the consumer discretionary sector. The Underlying Fund diverged the most from the benchmark sector weightings by having more exposure to the consumer discretionary sector and less exposure to the communication services sector.

Recent Developments

Portfolio manager Eileen Dibb is positive on Japan's equities as the economy transitions into a mildly inflationary state, following decades of stagnant growth and falling prices. The portfolio manager believes that wage increases will have a knock-on effect of boosting consumption and supporting further price gains. At the same time, the portfolio manager believes corporate governance reforms in Japan should continue to unlock equity market value, and companies may focus more on dividends and buybacks. As a result, the shareholder return profile of Japanese companies may improve faster than most other developed markets, in the portfolio manager's view. Against this backdrop, the portfolio manager continues to seek structurally competitive companies that the manager believes are consistently growing, with potentially improving returns to shareholders, as well as companies the manager believes appear inexpensively valued and are expected to recover.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$161,000 for the period ended May 31, 2024.

Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$28,000 for the period ended May 31, 2024.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

(i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;

(ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

- C Distributions were paid in cash or reinvested in additional securities of the Fund, or both, and excludes any applicable distributions of management fee reduction to securityholders.

- ¹ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate is not necessarily a short sale in the value of purchases of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.






