Management Discussion of Fund Performance

Results of Operations

Fidelity Global Growth and Value Class (Fund) invests substantially all of its assets in securities of Fidelity Global Growth and Value Investment Trust (Underlying Fund).

Fidelity Global Growth and Value Class, Series B, returned 19.2%, after fees and expenses, for the six-month period ended May 31, 2024. The net returns of the other series of the Fund are similar to those of Series B, except for differences attributable to expense structures. During the review period, global equities, as represented by the MSCI All Country World Index, returned 14.7% (in Canadian dollar terms).

Market overview:

Global equities, as broadly measured by the MSCI All Country World Index, returned 14.7% in Canadian dollar terms and 14.1% in U.S. dollar terms, for the six-month period ended May 31, 2024.

Global equities advanced during the review period, as resilient economic data and expectations for interest rate cuts, fuelled by decelerating inflation in developed markets, supported expectations for a soft landing in the global economy. Better-than-expected corporate earnings growth further encouraged investor confidence. However, markets were volatile as inflation remained well above the target range of most developed market central banks. Against this global backdrop, U.S., Japan, and Europe ex-U.K. equities rose. In Europe, equities posted robust returns, supported by resilient economic and corporate data as well as a slew of dovish cues from major central banks. Japanese equities also rose, driven primarily by central bank policy expectations, centred on the Bank of Japan and the U.S. Federal Reserve, accompanied by weakness in the Yen. Emerging markets also ended higher but lagged developed markets amid concerns around China's sluggish economic recovery. Investors were concerned about China's growth prospects in the absence of any meaningful stimulus and a suppressed housing market.

Factors affecting performance:

The Fund's benchmark returned 15.5% for the period under review. The Fund's benchmark is composed of 50.0% MSCI World Small Cap Index, and 50.0% S&P 500 Index.

The Fund outperformed its benchmark primarily due to the Underlying Fund's investments in, and higher-than-benchmark exposure to, the communication services sector. In this sector, investments in U.S.-based technology company Meta Platforms, and U.S.-based video streaming company Netflix, contributed to relative returns. Investments in the information technology sector also contributed to relative returns. In this sector, U.S.-based semiconductors company NVIDIA, and U.S.-based electronic connector manufacturing company Amphenol, both contributed to relative returns. In other sectors, lower-than-benchmark exposure to U.S.-based automotive and clean energy company Tesla, and an investment in U.S.-based pharmaceutical company Eli Lilly, contributed to relative returns.

There were no significant detractors over the review period. In other sectors, the Underlying Fund's holdings in U.S.-based health insurance company UnitedHealth Group, and U.S.-based home health care services company Humana, detracted from relative returns.

At the end of the review period, the Underlying Fund had no exposure to Tesla.

Portfolio chanaes:

During the review period, the Underlying Fund's exposure to the financials and communication services sectors was increased. In the financials sector, the portfolio managers initiated a position in U.S.-based investment and insurance company The Hartford Financial Services Group, as they believe the company has good investment growth potential. In the communication services sector, exposure was increased to Meta Platforms due to its dominant market position and strong growth potential, according to the portfolio managers.

In contrast, exposure to the energy and information technology sectors decreased. In the energy sector, the portfolio managers reduced exposure to U.S.-based oil and gas company ExxonMobil Corporation. In the information technology sector, exposure was reduced to U.S.-based consumer electronics company Apple. The portfolio managers pursued opportunities they believe have better investment upside potential.

At the end of the review period, the Underlying Fund had its largest absolute exposure to the information technology sector, followed by the financials sector. The Underlying Fund diverged most from its benchmark's sector weightings by having more exposure to the communication services sector and less exposure to the real estate sector. In terms of geographic exposure, the U.S. accounted for the Underlying Fund's largest absolute allocation.

Recent Developments

The portfolio manager of the growth sub-portfolio, Will Danoff, has an investment strategy that focuses on identifying "best of breed" companies with strong long-term business models and competitive advantages that, the manager believes, can achieve sustainable long-term growth leadership. The portfolio manager remains positive on the earnings environment and has leveraged periods of market volatility to increase concentration in the Underlying Fund's active holdings. The portfolio manager continues to have a positive outlook on big tech-related companies that are profitable, grow at above-average rates and operate in large and expanding markets. The portfolio manager is finding strength in some of the more growth-oriented areas of the market in a wide variety of sectors, due to attractively valued earnings growth potential, investable secular trends and a potential peak in interest rates, in the portfolio

manager's view.

The portfolio managers of the value sub-portfolio, Morgen Peck, Sam Chamovitz and Salim Hart, employ an intrinsic-value investment framework, using bottom-up fundamental analysis and quantitative techniques to identify high-quality companies that could compound returns over time in their view. They seek to mitigate downside risk by emphasizing what they believe are higher-quality companies with lower financial leverage, more consistent profitability and better management teams. The portfolio managers continue to favour Japanese companies, given that country's breadth of investment opportunities, in their view.

Effective December 31, 2023, Joel Tillinghast retired as a Portfolio Manager.

Related Party Transactions

Manager and Portfolio Adviser

The Fund is managed by Fidelity Investments Canada ULC (Fidelity). Fidelity is part of a broader collection of companies collectively known as Fidelity Investments.

Fidelity provides or arranges for the provision of all general management and administrative services required by the Fund in its day—to—day operations, bookkeeping, record—keeping and other administrative services for the Fund.

Fidelity is the portfolio adviser to the Fund and it provides investment advisory services to the Fund. Fidelity has entered into sub-advisory agreements with a number of entities including Fidelity Management & Research Company LLC, to provide investment advice with respect to all or a portion of the investments of the Fund. The sub-advisors arrange for acquisition and disposition of portfolio investments, including all necessary brokerage arrangements. The Fund pays Fidelity a monthly management and advisory fee for their services, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity management and advisory fees of \$16,268,000 for the period ended May 31, 2024.

Administration Fee

Fidelity charges the Fund a fixed administration fee in place of certain variable expenses. Fidelity, in turn, pays all of the operating expenses of the Fund, other than certain specified fund costs (e.g. the fees and expenses of the Independent Review Committee, taxes, brokerage commissions and interest charges). The Fund pays an annual rate, which is calculated on a tiered basis, based on the net asset value of each Series, calculated daily and payable monthly. The Fund paid Fidelity administration fees of \$1,676,000 for the period ended May 31, 2024.

Independent Review Committee, Cross-Trading and In specie Transactions

Independent Review Committee

Fidelity has established an independent review committee (IRC) that acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting conflict of interest matters referred to it by Fidelity. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available at www.fidelity.ca or at the securityholder's request at no cost by contacting Fidelity, using the contact information available on the final page of this document.

Cross-Trading and In specie Transactions

The Fund received the approval and standing instructions from the IRC in order to:

- (i) engage in cross-trading, which is a form of interfund trading. A cross-trade occurs when the Fund purchases or sells portfolio securities from or to another Fund, a U.S. fund or a separately managed account, through a broker;
- (ii) permit the Fund, in certain circumstances, to purchase and redeem Fund securities in consideration for securities rather than cash of another investment fund not governed by NI 81-102, or a separately managed account, managed by Fidelity.

For each of the transactions in (i) and (ii) above, the IRC's standing instructions require Fidelity to act in accordance with its associated policies and procedures and applicable law, and comply with the conditions in each of the exemptive relief orders received, which, in the case of cross-trading, requires additional periodic reporting to the Ontario Securities Commission. The standing instructions also require that investment decisions in respect of these transactions (a) are free from any influence by an entity related to Fidelity and without taking into account any consideration relevant to an entity related to Fidelity; (b) represent the business judgment of Fidelity uninfluenced by considerations other than the best interests of the Fund; (c) comply with the applicable policies and procedures of Fidelity; and (d) achieve a fair and reasonable result for the Fund.

There is not necessarily a relationship between a high portfolio turnover rate and the performance of the Fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales of securities divided by the weighted average market value of portfolio securities owned by the Fund, excluding short-term securities. The portfolio turnover rate includes any proceeds from a short sale in the value of sales of securities and the cost of covering a short sale in the value of purchases of securities. For periods greater than six months, but less than a full fiscal year, the portfolio turnover rate is annualized. The portfolio turnover rate excludes any adjustment for in-kind transactions.

Management and Advisory Fees

Fidelity serves as manager and investment advisor of the Fund. The Fund pays Fidelity a monthly management and advisory fee for its services, based on the net asset value of each Series, calculated daily and payable monthly. Fidelity uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund securities, as well as for the general investment management expenses. Dealer compensation represents cash commissions paid by Fidelity to registered dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by Fidelity during the period. For new Funds or Series the amounts presented may not be indicative of longer term operating periods.


